- (b) for any other athletes, he or she has notified HKADC at least six months in advance before he or she expects to return to an International Event, and during which period he or she has provided HKADC whereabouts information and has made himself/herself available for unannounced Out-of-Competition Testing.
- (c) WADA, in consultation with HKADC and the Athlete's International Federation, may grant an exemption to the six-month written notice rule where the strict application of that rule would be manifestly unfair to an Athlete. This decision may be appealed under Article 13. Any competitive results obtained in violation of this Article 5.7.1 shall be Disqualified.
- 5.7.2 Having given notice of retirement to HKADC, and having been formally deleted from the HKADC testing pool, an athlete may not resume competing at a National Event unless he/she agrees to make him/herself available for unannounced Out-of-Competition Testing.
- 5.7.3 If an Athlete retires from sport while subject to a period of Ineligibility the Athlete shall not resume competing in International Events or National Events until the Athlete has given six months prior written notice (or notice equivalent to the period of Ineligibility remaining as of the date the Athlete retired, if that period was longer than six months) to HKADC and to his/her International Federation of his/her intent to resume competing and has made him/herself available for Testing for that notice period, including (if requested) complying with the whereabouts requirements of Annex I to the International Standard for Testing and Investigations.

<u>香港運動禁藥委員會運動禁藥條例</u> 5.7 退休運動員復出參賽

- 5.7.1 被香港運動禁藥委員會納入其藥檢名單之中的運動員,一旦已向香港運動禁藥委員會提交退休通知,並已 正式從香港運動禁藥委員會之藥檢名單中除名者,不能再參與國際賽事,除非符合下列要求:
- (a) 任何曾被納入國際體育聯會藥檢名單或受其條例監管之運動員,如要復出參與國際比賽,則必須最少於六個 月、或所屬國際體育聯會訂明之有關通知期限要求前,以較嚴格者為準,提前通知相關國際體育聯會及香港運動禁藥委員會;並須要在上述期間內提交行蹤資料,隨時準備接受無預警賽外藥物檢測。
- (b) 任何有意復出參與國際比賽之運動員,已於最少六個月前通知香港運動禁藥委員會,並已在上述期間內提交 行蹤資料,接受無預警賽外藥物檢測。
- (c) 若嚴格執行六個月書面通知之要求會對運動員造成明顯不公,世界運動禁藥機構經咨詢香港運動禁藥委員會 及運動員所屬之國際體育聯會後,可對該要求作出豁免,任何人士可按照條例第13條對有關決定提出上訴。任 何在違反條例第5.7.1 條下取得之比賽成績將被取消。
- 5.7.2 運動員一旦已向香港運動禁藥委員會提交退休通知,並已正式從香港運動禁藥委員會之藥檢名單中除名, 則不能再參與本地賽事,除非該運動員同意隨時準備接受無預警賽外藥物檢測。
- 5.7.3 若運動員於停賽處分期間退休,其後有意復出參與國際或本地賽事,則必須最少於六個月(或按運動員退 休當天起計餘下六個月以上之停賽處分期)之前,向香港運動禁藥委員會及其所屬國際體育聯會提出書面通知, 並在該期間內隨時準備接受藥物檢測,包括遵守國際檢測及調查標準附件 I 關於提交行蹤資料之要求。
