

The 2019 Prohibited List Released



THE WORLD ANTI-DOPING CODE INTERNATIONAL STANDARD

JANUARY 2019

The World Anti-Doping Agency (WADA) has published the

2019 List of Prohibited Substances and Methods ("The Prohibited List"), which will come into force on 1 January 2019.

The Prohibited List is updated annually and is released a few months before it comes into effect to ensure athletes and their support personnel have sufficient time to familiarize themselves with the List and its modifications, review any medications they use and apply for a Therapeutic Use Exemption (TUE) if required.

All athletes and their support personnel are strongly advised to familiarize themselves with the 2019 Prohibited List and the Summary of Major Modifications and Explanatory Notes which lists out all the changes made. For example, one of the major changes is that the title of Prohibited Methods "M3" has been changed from "Gene Doping" to "Gene and Cell Doping".

The 2019 Prohibited List and the full summary can be downloaded on WADA's website at www.wada-ama. org. HKADC has also produced a pocket-size 2019 Prohibited List for athletes' use, please contact HKADC office if you would like a copy.

世界運動禁藥機構 (WADA)已推出 2019年度禁用物質

及方法清單(禁用清單),並將於 2019年1月1日生效。

WADA 每年都會更新禁用清單,並在其生效前數個月預先公佈,以確保運動員及支援人員有足夠時間熟悉新的禁用清單及其修訂、覆檢運動員正在服用的藥物,以及在必要情況下申請治療用藥豁免(TUE)。

本會慎重建議所有運動員及支援 人員詳閱 2019 年度禁用清單及 其修正摘要及註釋。舉例其中一 項主要變更:禁用方法 "M3" 的 名稱已由「基因禁藥」改為「基 因及細胞禁藥」。



2016年違反運動禁藥 2016 Anti-Doping Rule Violations

世界運動禁藥機構 (WADA) 剛發佈了 2016 年違反運動禁藥管制規條報告。於 2016 年間一共有 1,595 宗違規個案,當中 1,574 宗涉及運動員違規,而其餘 21 宗則與運動支援人員有關。

The World Anti-Doping Agency (WADA) has recently issued the 2016 Anti-Doping Rule Violations (ADRVs) Report. There were 1,595 ADRVs in total, among them 1,574 cases involved violation by athletes, while the remaining 21 cases were related to athlete support personnel.


