## 運動禁藥檢測程序知多啲 Know More About the Doping Control Process

為了建立公平的競賽環境,所有運動禁藥管制 組織必須根據世界運動禁藥機構(WADA)的 「藥物檢測及調查國際標準」,以同一準則 執行標準的運動禁藥檢測程序。不過,因應 特殊情況,運動禁藥管制主任(DCO)有權 在不影響樣本的「特性、安全和完整性」的 原則下,適當改動標準的尿液樣本收集程序。 以下是部份例子:

To preserve an environment for fair play in sport, all Anti-Doping Organizations must implement the standard sample collection procedures according to the World Anti-Doping Agency's International Standard for Testing and Investigations. However, Doping Control Officers (DCO) have the authority to make modifications on the standard urine sample collection procedures in exceptional circumstances as long as such modifications will not compromise the identity, security or integrity of the sample. Here are some examples:

## ●適用於殘疾運動員 Athletes With Impairment

- 1. 在標準的尿液樣本收集程序中,運動員的 樣本由選取集尿杯開始,直至樣本被密封 前必須由運動員本人處理。如運動員因殘 疾或受傷而未能自行處理樣本,在運動員 及 DCO 同意下,運動員代表或 DCO 可協助 執行部份程序,例如選取樣本瓶、將樣本 倒進樣本收集瓶、封存樣本等。
- 2. 使用尿液收集或排放系統的運動員,必須 在提供尿液樣本作藥檢前,在 DCO 監察下 清空系統中的尿液,或在情況許可下更換 新的系統。
- 1. In a standard urine sample collection procedure, only the athlete should retain control of his/her sample from choosing the collection vessel until the sample is sealed. An athlete with an impairment or injury may be assisted by an athlete's representative or the DCO, where authorized by the athlete and agreed by the DCO, to handle some of the procedures, such as selecting the sample collection kit, pouring the sample into the sample collection kit or sealing the sample.
- 2. Athletes who are using urine collection or drainage systems are required to eliminate existing urine from such systems before providing a urine sample for analysis under the DCO's direct observation, or replacing the existing system with a new one prior to the sample collection where possible.

## 適用於青少年運動員 Athletes Who Are Minors -

- 1. 如運動員未年滿 18 歲,在整個藥檢過程中 必須有一位成年人代表在場陪同,包括見 證運動員提供尿液樣本的過程。除非運動 員要求,否則該代表並不會直接觀察運動 員的排尿過程。此舉的目的為確保 DCO 按 照正常程序監察運動員排尿。
- 2. 如運動員拒絕由成年人代表陪同,則 DCO 必須確保有第三者在場作見証。
- 1. For athlete who is under the age of 18, an adult representative must be present throughout the entire sample collection session, which includes witnessing the urine sample provision process. The representative shall not directly observe the passing of the urine sample, unless requested to do so by the minor athlete. This is to ensure that the DCO is observing the sample provision correctly according to the standard procedures.
- 2. If athlete declines the presence of a representative, then a thirdparty representative of the DCO must be present.

To protect the rights of athletes, DCO will document all modifications made on the Doping Control Form.

## 模擬個案 Fictitious Case Study



Thomas 是一名精英運動員,長年累月的密集訓練及比賽令他深受傷患困擾。一個月前,Thomas 在訓練時觸及手腕的舊患,痛得連球拍也拿不起。由於 Thomas 兩日後要出戰亞錦賽,急於康復的他決定向中醫師求診。中醫師即時為他敷藥,並處方了五天份量的「天然草本止痛藥」給他服用。

Thomas 最後在亞錦賽中贏得第三名,並在賽後接受了大會安排的賽內藥物檢測。日前,Thomas 收到了國際聯會的違規通知,指控他在亞錦賽提供的尿液樣本含有賽內禁用物質。Thomas 後來發現中醫師處方的止痛藥中含有賽內禁用的麻醉劑。

Thomas is an elite athlete who constantly struggles with injuries owing to prolonged intensive training and competitions. A month ago, Thomas twisted his injured wrist again severely during training and that he couldn't even hold his racket. Since he was going to compete at the Asian Championships two days later, he wanted to recover quickly and hence decided to consult a Chinese Medicine Practitioner. The Practitioner treated him with herbal paste dressing and prescribed him with a 5-day dose of "Natural Herbal Painkiller".

Eventually, Thomas won a bronze medal at the Asian Championships and received in-competition doping test conducted by the event organizer after the competition. Recently, he received a Notice of Charge from his International Federation, alleging that prohibited substance was found in his urine sample collected during the Championships. Thomas later realized that the painkiller prescribed by the Chinese Medicine Practitioner contained narcotics which was prohibited in-competition.

## Thomas是否需要為誤用運動禁藥而負責呢? Should Thomas be responsible for inadvertent doping?



- 1. 根據世界運動禁藥法規, 無論運動員是否故意攝入, 都必須為其體內發現的禁用 物質負上全部責任。
- 2. 中草本植物種類繁多,而且生產及製作方法廣泛卻欠統一標準,運動員不能保證服用的中草藥沒有受污染或不含運動禁用物質。
- 3. 運動員服用中草藥前應慎重評估有關需要及潛在風險,同時考慮其他更安全的方法。
- 1. According to the World Anti-Doping Code, athlete is responsible for any prohibited substance found in his or her body, no matter if the prohibited substance is used intentionally or not.
- 2. Due to the vast variety of Chinese herbs and the extensive, non-standardized ways of production and preparation of Chinese herbal medicine, there is no guarantee that a Chinese herbal medicine does not contain or is not contaminated with prohibited substance(s).
- 3. Athlete should seriously assess the need and the potential risks before using Chinese herbal medicine while considering other relatively safer alternatives.

## 團結一致為清白運動員建立更美好的將來


## Uniting the anti-doping community to build a brighter future for clean athletes

每年三月在瑞士洛桑舉行的地區運動禁藥管制組織協會工作坊(iNADO工作坊)及世界運動禁藥機構年度會議(WADA年度會議)為運動禁藥管制組織提供一個良機,以掌握世界運動禁藥管制策略的最新發展及分享打擊運動禁藥的訊息。

今年的 iNADO 工作坊及 WADA 年度會議分別以「合作提升能力」及「攜手邁向 2021」為題,集中討論 2021 世界運動禁藥法規的草案及其他將會一同生效的國際標準。

本會將未雨綢繆確保香港的運動禁藥 管制計劃符合新的運動禁藥法規,並 繼續與運動禁藥管制組織團結一致, 維護正直廉潔的體育操守。





Under the theme of "Raising the Water Level" and "Towards 2021 – Navigating the Future Together" respectively, the iNADO Workshop and the WADA Symposium this year focused on reviewing the drafted 2021 Anti-Doping Code and its associated International Standards which would come into force along with the Code.

HKADC plans ahead to ensure that our anti-doping programme is in compliance with the new Code and continues to work with the anti-doping community to protect the integrity of clean sport.
