Section 4 – Privacy Statement

ATHLETE INFORMATION NOTICE

This Athlete Information Notice explains in more detail how your personal information will be used and processed to ensure harmonized, coordinated and effective anti-doping programs for detection, deterrence and prevention of doping.

Categories of personal information

- Your personal information is all information related to the Doping Control process including, but not limited to investigations, test distribution planning, athlete whereabouts, sample collection and handling, laboratory analysis, results management, hearings and appeals;
- The laboratory analysis results include: detection of a prohibited substance, its metabolites or markers or any evidence of use of prohibited method(s) identified on the WADA Prohibited List; detection of the presence of other substances not included in the WADA Prohibited List as may be directed by WADA pursuant to monitoring program described in Article 4.5 of the World Anti-Doping Code (Code); longitudinal profile of haematological parameters such as haemoglobin and red blood count over a specified period of time as well as T/E ratio; or results from other tests that may be developed in future to identify the presence of prohibited substances.

Disclosures

- Your personal information will be made available to authorized Anti-Doping Organizations - for instance, designated national anti-doping organizations, international or national sporting federations, or major games organizers - in accordance with the Code and processed in accordance with the anti-doping provisions of the Code; and
- Your personal information will also be made available, in part, to WADA, which will need to process certain information in order to fulfill its obligations and responsibilities under the Code;
- WADA-accredited laboratories will need to receive your specimens and possibly other data relating to you; however, such laboratories will only be provided with de-identified, key-coded data and specimens that will not enable the laboratories to identify you;
- The Anti-Doping Organizations, WADA and accredited laboratories will process your personal information only for the purpose of ensuring harmonized, coordinated and effective anti-doping programs in sport; and
- Anti-Doping Organizations, WADA, and accredited laboratories will not disclose any of your personal information other than to those persons within their organization on a need to know basis.

International Transfers

- Your personal information may be made available to persons or parties, including WADA and Anti-Doping Organizations, located outside Hong Kong; and
- Your personal information will be held in either (i) HKADC's secured filing system; or (ii) ADAMS, a web-based database management tool hosted in data centres located in Canada and maintained by WADA on behalf of Anti-Doping Organizations using ADAMS. Strong technological, organizational and other security measures have been applied to ADAMS to maintain the security of the data it contains.

Your Rights

- You have certain rights under the Personal Data (Privacy) Ordinance (Cap. 486) in relation to your personal information, including rights to access and/or correct any inaccurate data, and remedies and rights of redress for any unlawful processing of your personal information; and
- To the extent that you have any concerns about the processing of your personal information you may consult with HKADC's representative on 2890 3644, WADA (www.wada-ama.org), and/or your federation (in the event that your ADAMS account is created by your federation), as appropriate.

Retention

- Your personal information will be kept by HKADC or stored in ADAMS for a minimum period of ten years being the period within which an action can be commenced following a violation of an anti-doping rule contained in the Code.

Withdrawal of Consent

- You understand that you may at any time revoke consent for the processing of your personal information, although in that event, and as noted above, it still may be necessary for HKADC, Anti-Doping Organizations and WADA to continue to process (including retain) certain of your personal information to fulfill obligations and responsibilities arising under the Code and applicable laws.
- You also understand that your participation in organized sporting events is contingent upon your adherence at all times to the rules contained in the Code and your relevant sports organizations policies, including, among other things, your voluntary participation in anti-doping procedures set forth in the Code and thus the processing of your personal information as described in this form.
- You understand that the withdrawal of your consent to the processing of your personal information will be construed as a refusal to participate in those anti-doping procedures mandated by the Code. This could exclude you from further participation in organized sporting events, and may result in disciplinary or other sanctions being imposed upon you, such as disqualification from competitions in which you are scheduled to participate or the invalidation of results arising from prior competitions.

Release

- By signing the Athlete's Consent Form you will release HKADC, WADA, as well as other relevant Anti-Doping Organizations, from all claims, demands, liabilities, damages, costs and expenses that you may have arising in connection with the processing of your personal information through HKADC or ADAMS.
